## Campground Rules

### **General Rules**

1. During any scheduled district activity all persons on the campground are under the jurisdiction of the Campground Rules.
2. All campers must register with the Camp Principle or designated person as soon as possible upon their arrival at the campground.
3. Campers are responsible and liable for any property damage incurred by them or one of their family members.
4. Campers will attend all scheduled activities and services unless they are working or attending to other areas of need.
5. A North Dakota Apostolic pastor must personally sign the registration form of each camper and the camper must also sign, indicating they have read the rules and pledge to abide by them.
6. Campers will be responsible for the actions of their children and any guests they have on the campground.
7. Watercraft will not be used or launched from the UPCI campground without permission.
8. Campers must clean up their sites and pay any hookup fees prior to their leaving the campgrounds.
9. In courtesy to all campers, the cafeteria and campground will be closed to all noise and activity by 1:00 am or at the discretion of those in charge.
10. Single youth must have permission to leave the grounds for any reason, and all cars will be parked except for attending scheduled activities off the campground.
11. No alcohol, tobacco, un-prescribed drugs and worldly music are allowed on the campground.
12. Young people staying in dorms, tents or campers will be subjected to the rules as set down by their supervisors and/or Camp Principle

### **Dress Code**

1. Men, women and young people should wear modest clothing which pertains to godliness and should be dressed appropriately at all times. Our desire is not to keep people from coming to camp for lack of certain clothing, but to maintain a godly atmosphere and a place of refuge from the world.
2. Men should not wear tight or form fitting pants and shirts that are immodest and expose the body; this also includes sleeveless shirts and tee shirts which are considered an undergarment. There should be no suggestive logos or pictures on shirts and pants. Men should not wear jogging shorts or any other type of short style trousers. All men must have a decent haircut with hair off the collar and ears
3. Women should not wear tight or form fitting clothing which immodestly exposes the body. Pants, shorts, capped, or sleeveless shirts are not acceptable. All skirts and slits must be a modest length below the knee.
4. Make-up, necklaces, earrings, etc. are not permitted on the campground.
5. Please note, that there is a separate District Platform Policy Dress Code for district events (please consult your pastor)
